Lead Warning Statement

Housing built before 1978 may contain lead-based paint. Lead from paint, paint chips, and dust can pose health hazards if not managed properly. Before renting pre-1978 housing, lessors must disclose the presence of known lead-based paint and/or lead-based paint hazards in the dwelling. Lessees must also receive a federally approved pamphlet on lead poisoning prevention.

SUMMARY OF LEAD-BASED PAINT INFORMATION

Dear Sir or Madam:

Federal law requires that owners of housing constructed prior to 1978 provide to prospective tenants a copy of the pamphlet "Protect your Family from Lead in Your Home" and a copy of any reports or records pertaining to the presence of lead-based paint or lead-based paint hazards that have been identified in the housing. Please be advised that limited testing of certain building components at the Divinity Apts –350 Canner Street-Curtis Hall in 1998 & 2006 identified lead-based paint on the following surfaces:

1998- Exterior entry ways, exterior door frames, exterior railings, exterior portico rail columns.

2006- Exterior windows

Exterior windows and upper trim have been encased by a Connecticut approved lead encapsulant product in 2007.

A copy of the limited lead-based paint testing data can be reviewed at the office of the Divinity Facilities Superintendent, located at Bellamy Hall Rm 631, or may be obtained through Yale's Office of Environmental Health and Safety at 737-4453 (Attn: Steve Murdzia).

Lead based paint that is in good condition does not pose a hazard. However, to be safe, please be sure to follow the guidelines in the pamphlet, which include preventing your children from the dangers of lead paint dust.

If you notice that any painted surfaces in the building are deteriorating (chipping, peeling, etc.), please notify the Graduate Housing Office initially at 432-8270 or Steven Murdzia of Yale's Office of Environmental Health and Safety at 737-4453. In addition, please contact Mr. Murdzia if you have any questions or if you would like a copy of the limited lead-based paint testing data.
